ACT 1 and 2 TEST  
December 30, 2017



**Location:** Ann Arbor Dog Training Club Wight Training Center 1575 East North Territorial Road, Whitmore Lake, MI 48189-9481

**Who is eligible?** Dogs that are 15 months or older and do not have an AKC agility title. They must meet the requirements of a regular trial (Chapter 1, Section 3) except they do not have to be AKC registered to entered.

**ACT Level 1:** 10 -12 obstacles which includes a 5 ft Aframe, table, tunnel, bar jumps (no spreads). The Tire and panel are allowed but not required. Time for the course will be 60 seconds and a score of 85 is required.

**ACT level 2:** 11 - 13 obstacles including all those in Level 1 plus the teeter, tire, 1 spread jump and 6 weaves. Time for the course will be 70 seconds and a score of 85 is required.

**Judging:** Refusals and Run outs are not judged. More than 3 attempts will result in an elimination/failure to perform. Table faults, wrong courses, failure to perform will be judged as in regular trials. Two passing scores are needed for a title

**Jump height:** The exhibitor can choose what height to jump (4, 8, 12, 16, 20, 24). No measurement is required.

**Entry:** Pre-entry is \$15/run (includes \$5 AKC recording fee) and must be received by December 28. Day of Show entry is \$20 (includes \$5 AKC recording fee). Maximum entry is 30 per trial. Day of show entries will only be accepted if the limit has not been reached by Saturday morning. Call/text 248-345-1735 to check if you are considering day of show and want to know if the trial is filled.

**Schedule:** Day of show entries will be taken from 9 - 9:30 if the limit has not been met. 9:30 - 10 . Briefing at 10:15 followed by 8 minutes to walk the course. First run at 10:30. ACT 1 Trial one will be followed by 15 minute break and then ACT 1 Trial 2. After an hour break ACT 2 trial 1 will be followed by ACT 2 Trial 2. If you wish to move up after ACT 1,

you may enter ACT 2 if the limit has not been reached. Food will not be available but there is a Subway a short distance from the club.

**Awards.** All qualifiers will receive a green qualifying ribbon

**Entries** will be accepted on a first received basis. The form must be completed and signed and include a check for the correct amount. Emailed, phone, or fax entries will be accepted. Returned checks will not constitute a valid entry and a \$30 charge will be collected. No refunds will be given for dogs who are absent, excused or barred from competition. Refunds will be given for bitches in season upon inspection or a letter from a veterinarian.

#### ***DIRECTIONS TO THE SHOW SITE & MOTEL INFORMATION***

*From Lansing:*

I-96 east to U.S. 23 south to North Territorial exit #49. East (left) from exit ramp. Approximately 1 mile east. AADTC facility is on the north (left) side immediately beyond the railroad tracks

*From Detroit:*

I-96/M-14 west to Gotfredson exit. Right to North Territorial. Left on North Territorial. Approximately 8 miles west. AADTC facility is on the north (right) side immediately past Nollar Road and before the railroad tracks.

*From Toledo or Ann Arbor:*

U.S. 23 north to North Territorial exit #49. East (right) from exit ramp. Approximately 1 mile east. AADTC facility is on the north (left) side immediately beyond the railroad tracks.
